

<b>FACTS</b>	<b>WHAT DOES ALLSTATE HEALTH SOLUTIONS DO WITH YOUR PERSONAL INFORMATION?</b>
<b>Why?</b>	Financial companies choose how they share your personal information. Federal and state laws give consumers the right to limit some but not all sharing. These laws also require us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Name, phone number, home/email address, and other contact information, marital status, and family member information</li> <li>• Social Security number, driver's license number, credit information, and credit scores</li> <li>• Medical information, medical records, and health history</li> <li>• Customer files including claims, payment and transaction history, policy coverage, and premiums</li> </ul>
<b>How?</b>	Financial companies need to share customers' and former customers' personal information to run their everyday business. In the section below, we list the reasons companies can share their customers' personal information; the reasons Allstate Health Solutions choose to share; and whether you can limit this sharing.

<b>How does Allstate Health Solutions protect my personal information?</b>	We use a variety of physical, technical, and administrative security measures that help to safeguard your personal information. We require our employees and people or organizations that represent us to protect your information and keep it confidential.
<b>How does Allstate Health</b>	We collect your personal information, for example, when you

Solutions collect my personal information?	<ul style="list-style-type: none"> <li>• Apply for insurance or give us your contact information</li> <li>• Pay your insurance premium or file an insurance claim</li> </ul> <p>We also collect your personal information from others, such as affiliates, credit bureaus, and insurance support organizations (which may retain and share your information with others). In addition, Allstate Health Solutions and its business partners gather information through Internet activity, which may include, for example, your operating system, links you used to visit our site, web pages you viewed while visiting our site, or applications, Internet Protocol (IP) addresses, and cookies.</p>
Why can't I limit all sharing?	<p>Federal and state law gives you the right to limit</p> <ul style="list-style-type: none"> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for nonaffiliates to market to you</li> </ul> <p>State law may give additional rights to limit sharing. See below for more on those rights.</p>
How else does Allstate Health Solutions use and share personal information?	<p>We will also disclose your personal information without notice when necessary to: (a) fulfill a transaction you requested, service your policy or handle your claim; (b) market our products; (c) comply with the law or regulatory and law enforcement authority requests; (d) protect and defend our customers, rights, or property; (e) act under emergency circumstances to protect the personal safety of customers or the public; (f) transfer corporate ownership; (g) conduct research, actuarial studies, or audits; and (h) facilitate an insurance institution, producer, medical institution/professional, or support organization to process claims, verify coverage or benefits or perform other insurance functions. We will not use your medical information for marketing purposes without your consent.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	<p>Your choices will apply to everyone on your account.</p>
How can I review or correct my data?	<p>You may access your recorded personal information under our possession for the previous two years and to request a correction, amendment, or deletion of such recorded personal information by sending a request to:</p> <p>Allstate Health Solutions, Attention: Privacy Office 1515 N.
